1. The above posts are purely temporary and on a contractual basis till the termination of the project. The selected candidates shall not claim for regular appointment/absorption in ICAR-IIMR or funding agency at the end of the project.
2. The age limit of the above position is up to 35 years as of the date of the interview. The relaxation in the upper age limit is five years for SC/ST/women candidates and three years for OBC candidates as per the rules.
3. The duly filled-in application form (as per the format-Annexure I enclosed) with a photograph affixed on it and signed, should be sent to **globalcoemilletts@milletts.res.in** on or before **27th October, 2023**.
4. All the relevant original testimonials (date of birth, degree certificate, experience certificate, etc., if any) are to be shown and a set of attested copies of all the certificates will be required to be submitted by the candidates for verification, before joining, if selected. ***If any candidate is found to have submitted false information/claims at any stage, their candidature will be summarily rejected or the appointment will be terminated.***
5. No objection and experience certificate are required from the employer; in case he/she is employed.
6. ***For short-listed candidates, the interview will be held online on 02nd November 2023 and the details of which will be communicated through email.***
