2. The age limit of above position is up to 35 years as on the date of interview. The relaxation in upper age limit is five years for SC/ST/women candidates and three years for OBC candidates as per rules.
3. The duly filled-in application form (as per the format-Annexure I enclosed) with photograph affixed on it and signed, should be sent to nepolean@millets.res.in on or before ***18th April, 2022.***
4. All the relevant original testimonials (date of birth, degree certificate, experience certificate, etc., if any) are to be shown and a set of attested copies of all the certificates will be required to be submitted by the candidates for verification, before joining, if selected. ***If any candidate is found to have submitted false information/claims at any stage, their candidature will be summarily rejected or appointment will be terminated.***
